The issue and availability for trading, through Monte Titoli S.p.A., of the Conversion Shares subscribed by the Warrant holders during the First Exercise Period will take place on the settlement day following the end of the last day of the First Exercise Period.

The Conversion Shares will have dividend rights equal to those of the MeglioQuesto Ordinary Shares traded on Euronext Growth Milan on the date of issue of the Conversion Shares.
